

Norfolk County Council proposes to make a Temporary Traffic Regulation Order (the "Order") (NTRO11064) affecting the A1067 Pensthorpe Road / Fakenham Road / Norwich Road from its junction with A1067 Clipbush Lane to its junction with U35221 Guist bottom Road (the "Road") in the Town/Parish of Fakenham and Stibbard to facilitate road marking and lining, the Road will be temporarily closed (except for pedestrian access) for the duration of the works/period the closure is necessary which is anticipated to be between 19:00 and 05:00 from 28th April to 1st May 2026, but may continue to be closed/restricted until the 12th June 2026 where the closure is still required beyond the anticipated dates.

Alternative route is via: A1067 Norwich Road, B1110 Bridge Road / Broom Green / Broom Green Road / High Street / Holt Road, B1145 Brisley Road/ Elmham Road, / Church Street / Stanfield Road / Fakenham Road / The Street / Litcham Road / Back Street / Lexham Road, A1065 Swaffham Road / Gravelpit Hill / Raynham Road / Roundabout Leading To Fakenham Bypass, A148 Fakenham Bypass, A1067 Clipbush Lane /Morrisons Roundabout / Pensthorpe Road (Fakenham, Wellingham, Guist, North Elmham, Litcham, Weasenham All Saints, Raynham, Lexham, Brisley, Sculthorpe, Stanfield, Hempton, Weasenham St. Peter, Dunton, Mileham).

The works promoter for this restriction/closure is: Norfolk County Council.

Vehicular access will be permitted to a final destination in the Road where signs indicating such access is possible and permitted are in place.

The Order shall automatically revoke on the completion of the works when the closure is no longer necessary or otherwise on the 12th June 2026 without further notice.

If necessary, the restriction could run for a maximum period of 18 months from the date the Order is effective.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

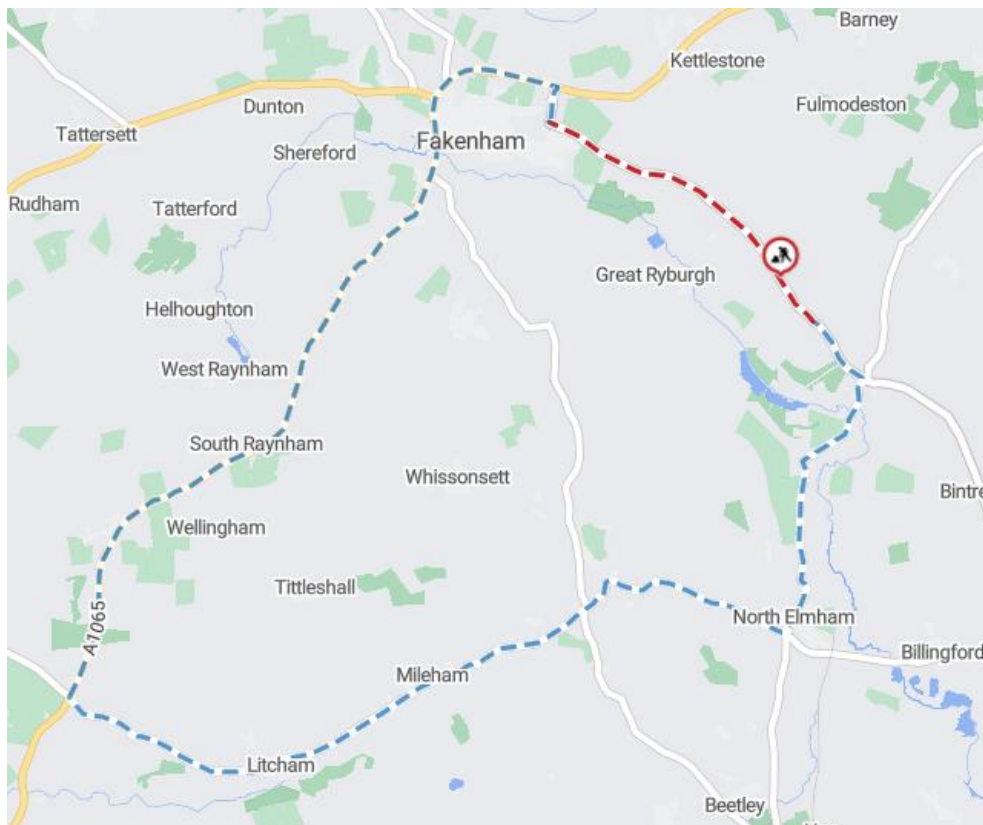
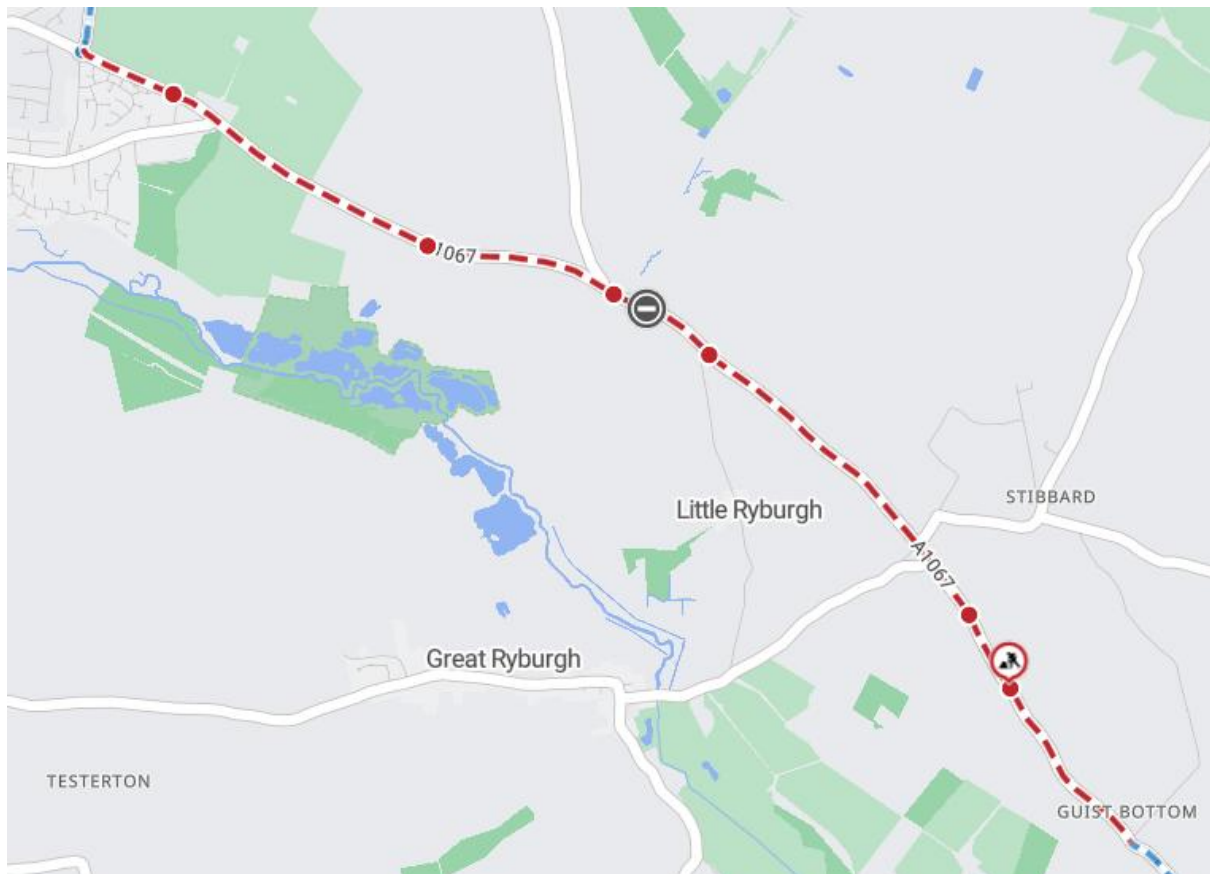
In the event of the start date being delayed the new start date will be displayed on site in advance.
